

actions, which the Court dismissed without prejudice by order entered November 22, 2024, shall be **DISMISSED WITH PREJUDICE**.

2. Upon entry of this Order, all pending motions, petitions, appeals, demands for satisfaction, and claims that are now pending, or that could be asserted by the Parties against one another or any of their agents, insurers, or assigns as of the entry of this Order, shall be fully and finally withdrawn, waived, released, and/or dismissed with prejudice, including, without limitation, the Defendants' pending appeals in Tennessee Court of Appeals Case Nos. M2024-01767-COA-R3-CV, M2024-01085-COA-R3-CV, and M2024-01082-COA-R3-CV.

3. Court costs in this court and on appeal shall be taxed to the Plaintiffs. The Parties shall otherwise bear their own attorney's fees and expenses.

4. This constitutes a final and conclusive resolution of the above-captioned case. The Clerk shall enter a final judgment pursuant to Tennessee Rule of Civil Procedure 58. Upon entry of this Order, any outstanding motions shall be **DENIED AS MOOT**.

5. The Parties waive all further rights of appeal.
