AGREED ORDER OF DISMISSAL WITH PREJUDICE

It appears to the Court, as evidenced by a review of the record and by the signatures of counsel for the respective parties below, that Plaintiff Pamela Perry's (hereinafter "Plaintiff") claims in this litigation are to be dismissed with prejudice pursuant to Plaintiff's agreement not to appeal this Court's granting of Defendants Nashville Convention & Visitor Corp., Marcus Lemonis, and Camping World, Inc.'s (hereinafter collectively, "Defendants") respective motions to dismiss in exchange for Defendants' agreement not to pursue attorneys' fees pursuant to Tenn. Code Ann. § 20-12-119(c). All motions currently pending before the Court are withdrawn, including Defendants Nashville Convention & Visitor Corp.'s and Camping World, Inc.'s respective motions for attorneys' fees. It is therefore,

ORDERED that all claims of the Plaintiff, Pamela Perry, are hereby dismissed with prejudice. Any outstanding court costs shall be taxed 2/3 to Plaintiff Pamela Perry and 1/3 to Defendant Nashville Convention & Visitor Corp, for which execution may issue if necessary.
