Come now the Parties, Nandigam Neurology, PLC, and Kaveer Nandigam, M.D. (“Plaintiffs”), and Kelly Beavers (“Defendant”), through undersigned counsel of record, and jointly submit the instant Agreed Final Order for the Court’s approval. As evidenced by the signatures of adversary counsel below, all remaining matters in controversy have been settled and compromised, and subject to the Court’s approval, the Parties have agreed to the following conclusive resolution of this action:

1. This case comes before the Court upon remand from the Tennessee Court of Appeals. On June 18, 2021, the Tennessee Court of Appeals ordered as follows:

The order of the General Sessions Court for Wilson County is affirmed and this case is remanded for further proceedings consistent with this opinion. On remand the general sessions court shall award Defendant her costs and reasonable attorney’s fees incurred at both the trial and appellate level and shall resolve Defendant’s outstanding request for sanctions against Plaintiffs pursuant to section 20-17-107(a)(2). We express no opinion regarding the outcome of Defendant’s request for additional sanctions.

2. The Court of Appeals' Amended Mandate issued on September 15, 2021. Accordingly, jurisdiction has been returned to this Court, which has been ordered to "award Defendant her costs and reasonable attorney's fees incurred at both the trial and appellate level and . . . resolve Defendant's outstanding request for sanctions against Plaintiffs pursuant to section 20-17-107(a)(2)." *Id.*

3. The Parties have reached resolution as to the proper cost, attorney's fees, and sanctions award that should issue upon remand consistent with the Court of Appeals' mandate. Accordingly, pursuant to Tenn. Code Ann. § 20-17-107(a), the Parties stipulate that **JUDGMENT SHALL ISSUE** in favor of Defendant Beavers against Plaintiffs Nandigam Neurology, PLC, and Kaveer Nandigam, M.D., and the Plaintiffs are hereby **ORDERED** to pay Defendant Beavers, through her counsel, Horwitz Law, PLLC, **FIFTY THOUSAND DOLLARS (\$50,000.00)**, jointly and severally—inclusive of all claims for reasonable attorney's fees before this Court and on appeal, discretionary costs, expenses incurred, and sanctions—which the Plaintiffs stipulate is reasonable.

4. Statutory interest shall accrue upon entry of judgment. In the event that: (a) installment payments of at least \$833.33 per month are made by the Plaintiffs by the first of each month beginning April 1, 2022, and (b) the judgment is satisfied in full by April 1, 2027, Defendant Beavers agrees not to execute on the judgment other than the placement of liens.

5. This constitutes a final and conclusive resolution of the above-captioned case. Upon entry of this Order, all other claims that were or could have been brought by the Parties in Case No.: 2020-CV-152 shall be deemed waived, withdrawn, and/or denied as moot. The Parties additionally waive all further rights of appeal.

6. The court costs of this action are taxed against Plaintiffs Nandigam


Neurology, PLC, and Kaveer Nandigam, M.D., for which execution may issue if necessary.




